## *Integrating Thinking* Payment plan for INPP Practitioner's Course: 2025

## Terms and conditions

• Enrolment in Module 1 and one of the payment plans outlined below assumes enrolment in the whole course.

• **Cancellation and administrative fees** apply should you not complete all 4 Modules.

These cancellation fees override those stated in the course flier. All other terms regarding dates for cancellations, if not noted below, remain as stated in the course flier. If you withdraw from the course, you must cover the full price quoted for the modules already delivered at the time of your withdrawal **and**, depending on when you withdraw, the following fees will also apply:

- After Module 1 and up to 7 days before Module 2 delivery: 15% of the full remaining course fees.
- Cancellations within 7 days of the first day of Module 2: full fees of Module 2 plus a \$330 (incl GST) administration fee will apply.
- After Module 2 and up to 7 days before delivery of Module 3: \$1500 fee.
- After Module 3 and up to 7 days before delivery of Module 4: \$500 fee.
- Cancellations within 7 days of the first day of the delivery of Modules 3 or 4 will incur the full fees of those modules.

• If your circumstances change and you would like to return to the standard fee structure, a payment amount/process including remaining funds owed and alignment with the existing standard payment structure, as well as a possible administration fee will be considered and negotiated with you.

• There are 2 payment plan options outlined (one fortnightly payment schedule, and one monthly payment schedule). Please select one that suits your circumstances or negotiate an alternative plan with Integrating Thinking before January 28th, 2025. First payment is due January 30<sup>th</sup>, 2025

• Payments are to be made by **direct deposit or through credit card facilities provided by** *Integrating Thinking*. Additional administrative fees for credit card payments may be incurred.

Payment arrangements need to be confirmed with *Integrating Thinking* prior to commencement of the course.

If the minimum number of participants is not achieved when registrations are closed, and the course is cancelled, refunds, or a position in an alternative course/course structure will be offered.
